Willie Taylor et ux To Livingston Texas Chapter of F.F.A. Deed

THE STATE OF TEXAS | KNOW ALL MEN BY THESE PRESENTS:

THAT WE, Willie Taylor and wife, Roxie B. Taylor, of the County of Polk, State of Texas for and in consideration of the sum of two thousand five hundred (\$2,500.00) dollars to us in hand paid by The Livingston Lions Club, of Livingston, Texas, for the use and benefit and for the term hereinafter stated and with the right of reversion hereinafter set out, cash, the receipt of which is hereby acknowledged, have granted, sold and conveyed, and by these presents do grant, sell and convey unto the Livingston, Texas Chapter of the Future Farmers of America, of the County of Polk, State of Texas all that certain twenty (20) acres of land, more or less, a part of the Peter Cauble Survey in Polk County, Texas described as follows;

Beginning in the center of the Livingston and Hortense Road at the southeast corner of said 20 acre tract, a stake for corner from which a pine mkd X bears N $4\frac{1}{2}$

Thence north 428 varas with the east boundary line of said 20 acre tract to the northeast corner of same a stake for corner from which a pire brs S 52 W 6 vrs and a hickory 10" dia mkd X bears S 7 W 12 vrs;

Thence west with the north boundary line of said 20 acretract at 165 varas pass the northeast corner of the Tempie Fackler 10 ac. tract (a stake for corner from which a pine mkd X bears east 8 varas and a sasafrass mkd X bears N 45 W 3 varas) continuing west a total distance of 265 varas to the northwest corner of the Tempie Fackler 10 acretract a stake for corner from which a pine 15" in diameter marked X bears witness;

Thence S 28 W 57 varas along the old Moscow road to a stake for corner from which a pine marked X bears witness;

Thence S 17 E with the line of the Sam Mills 25.68 acre tract a distance of 487 varas to a stake for corner in the Livingston-Hortense Road from which a pine marked X bears witness; said corner being the most eastern corner of said Sam Mills 25.68 acre tract;

Thence N 58½ E withs aid Livingston-Hortense Road at 83½ varas pass the southwest corner of the Aden Burks 10 acre tract (an iron stake set in the north margin of said road), continuing N 58½ E a total distance of 167 varas to the place of beginning, containing 20 acres of land, more or less. And being the same land and premises described in that certain deed from Sam A.Fackler et al to W.Taylor, dated January 3, 1953, as the same appears of record in Volume 157, page 377 of the Deed Records of Polk County, Texas, to which deed and the deed references contained within, and their respective recordings in the Deed Records of Polk County, Texas, reference is here made for all pertinent purposes.

To have and to hold the above described premises, together with all and singular the rights and appurtenances thereto in anywise belonging unto the said Livingston, Texas Chapter of the Future Farmers of America, subject to the terms and provisions above stipulated, and to its possible reverter forever; and we do hereby bind ourselves, our heirs executors and administrators, to warrant and forever defend all and singular the said
